Where any change in the constitution of the firm takes place, the current licence shall be deemed to be valid for a maximum period of three months from the date on which the change takes place unless, in the meantime, a fresh licence has been taken from the Licensing Authority in the name of the firm with the changed constitution.

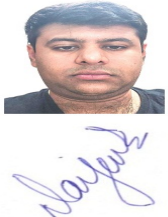

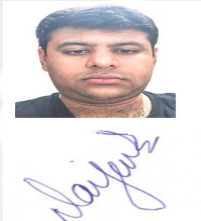

This licence will be deemed to extend to the categories of drugs in respect of which such permission is given. This permission shall be endorsed on the licence by the Licensing Authority.
3. No drug shall be sold unless such drug is purchased under a cash or credit memo from a duly licensed dealer or a duly licensed manufacturer.No sale of any drug shall be made to a person not holding the requisite 1[licence to sell, stock or exhibit for sale, or distribute] the drug. Provided that this condition shall not apply to the sale of any drug toâ€” an officer or authority purchasing on behalf of Government, ora hospital, medical, educational or research institution or a registered medical practitioner for the purpose of supply to his patients, ora manufacturer of beverages, confectionery biscuits and other non-medicinal products, where such drugs are required for processing these products.
4. The Licensee shall inform the Licensing Authority in writing in the event of any change in the constitution of the firm operation under the licence.
